


After perusing the opinion of the Consultant and brief examination of the contents of the Petition of the Chief Engineer (Power), Electricity Department, Government of Manipur including its enclosures, this Commission is satisfied that the Petition of the Petitioner for ARR and Retail Tariff for the FY 2014-15 be admitted (allowed) provisionally. The public notice detailing the salient information and facts of the ARR and Tariff Petition to be published by the Petitioner in the local newspapers for wide circulation seeking comments from all stakeholders and general public is to be issued to the Department for further publication within 23<sup>rd</sup> January, 2014.</p> <p>5.
